Who's Lobbying Who in BC? Monthly Snapshot - March 1 to March 31, 2011

The following organizations and consultant lobbyists submitted their registrations under the BC Lobbyists Registration Act between March 1 and March 31, 2011. The full details of each registration are searchable at www.lobbyistsregistrar.bc.ca.

- Michael Brooks, a consultant lobbyist for Brooks and Brooks Associates, is arranging meetings between his client, the Coalhunter Mining Corporation, and various public office holders to discuss his client's mining activities in BC.
- Josh Christensen, a consultant lobbyist for Hill and Knowlton, is arranging meetings between his
 client, the Health Sciences Association of BC, and the Minister of Advanced Education, the Minister
 of Health and the Minister of Labour, Citizens' Services and Open Government (and/or their staff) to
 introduce his client.
- 3. Carol-Ann DaSilva, an in-house lobbyist for Allergan Inc., is lobbying various public office holders to encourage the development of a policy to improve patient access to bariatric surgery.

Marko Dekovic, a consultant lobbyist for Canadian Strategy Group, is lobbying the Minister of Energy, the Minister of State for Climate Action and the Parliamentary Secretary for the Natural Gas Initiative to the Minister of Energy (and/or their staff) on behalf of his client, Capital Power Corporation to encourage the development and maintenance of a positive business environment for Clean Energy generation projects and related activities in BC.
