Who's Lobbying Who in BC? Monthly Snapshot – November 30, 2013

The following organizations and consultant lobbyists submitted their registrations under the BC *Lobbyists Registration Act* between November 1 and November 30, 2013. - 32. The Institute of Chartered Accountants of BC is lobbying the Minister of Advanced Education, Ministry staff and several MLAs for legislative changes required for the unification of BC's three accounting bodies.
- 33. The Massage Therapists' Association of British Columbia is lobbying the Minister of Advanced Education to develop an undergraduate degree in massage therapy and the Minister of Health to discuss scope of practice and regulations for Registered Massage Therapists.

- 36. Teck Metals Ltd. is lobbying the Minister of Environment for equivalency between B.C.'s Greenhouse Gas (GHG) Regulations and Environment Canada Base Metal Smelting GHG Regulations.
- 37. Teck Resources Limited is lobbying the Minister of Energy and Mines regarding the electricity rates review and the Minister of Energy and Mines and the Minister of Advanced Education for skills training support.
