## Who's Lobbying Who in BC?

## Monthly Snapshot - September 1-30, 2012

The following organizations and consultant lobbyists submitted their registrations under the BC Lobbyists Registration Act between September 1 and September 30, 2012. The full details of each registration are searchable at www.lobbyistsregistrar.bc.ca.

- Shannon Coombs and Cheryl Fougere, in-house lobbyists with the Canadian Consumer Specialty
  Products Association, are lobbying various MLAs and the Office of the Premier to modify the
  legislation related to pest control products.
- 2. Jim Favaro, an in-house lobbyist with Amgen Canada Inc., is lobbying several public office holders on a number of topics including reimbursement of their biotech medicines.
- 3. Jeff Gaulin, an in-house lobbyist with Tervita Corporation, is lobbying a number of ministers on environmental regulation related to reclamation of abandoned oil and gas infrastructure and potential management of industrial waste.
- 4. Bruce Hallsor, a consultant lobbyist, is lobbying the Minister of Finance and the Minister of Environment (and/or their staff) on behalf of his client, Boat Harbour Legacies Ltd., regarding the development of property near Nanaimo and the transfer of surplus property to a neighbouring provincial park.

- 10. In-house lobbyists with West Fraser Timber Co. Ltd. are lobbying several public office holders on a broad range of topics including job creation opportunities and potential bioenergy electricity sales agreements.
- 11. Mark Jiles, a consultant lobbyist with Canadian Strategy Group, is coordinating a meeting with the Minister of Environment on behalf of Canadian Tire Canada to raise awareness about Canadian Tire's policy position with respect to environmental stewardship.
