

Monthly Snapshot – September 30, 2017

The following organizations and consultant lobbyists submitted their registrations under the B.C. *Lobbyists Registration Act* and they were activated between September 1 and September 30, 2017. Here is a brief summary of lobbying activities organizations and consultant lobbyists have or expect to carry out. - 1. Jeff Andrus, Michael Gardiner, Geoff Ingram and Kimanda Jarzebiak, consultant lobbyists with Ascent Public Affairs, are lobbying a number of public office holders on behalf of Lyft Inc. to discuss what an appropriate transportation regulatory regime needs to be to effectively manage, encourage and monitor ridesharing within the broader sharing economy.
- 2. Jeffrey Andrus and Michael Gardiner, consultant lobbyists with MG Strategies, are lobbying a number of public office holders on behalf of the Motion Picture Association Canada to have input into the development and implementation of policies, regulations and legislation affecting the motion picture industry.
- David Angus and Yash Dogra, a consultant lobbyists with The Capital Hill Group, are lobbying several public office holders on behalf of RYCOM to introduce RYCOM's products and services within the facilities management sector of real-estate services.

- 34. Airbnb Canada Inc. is lobbying a number of public office holders regarding the development of policies to support the growth of the sharing economy in British Columbia, and tax compliance policies to support and provide clarity on home sharing.
- 35. The BC Dental Association is lobbying MLA Shane Simpson (Vancouver-Hastings) to improve MSDSR dental plans and to increase preventative care.

- 36. Becton Dickinson Canada Inc is lobbying several public agencies on a number of issues, including managing high-risk drugs, medication errors, healthcare worker safety, lab safety and public sector investments in long-term care and residential care.
- 37. The British Columbia Medical Association is lobbying the Minister of Health concerning their eight policy papers with the intent of public release and promotion to the government.
- 38. The B.C. Pharmacy Association is lobbying the Premier, the Minister of Health and the Minister of Mental Health and Addictions to advance the practice of community pharmacy in the province and to gain support for pharmacist services.
- 39. The Canadian Association of Petroleum Producers is lobbying a number of public office holders on a range of issues including clarity, efficiency and practicality regarding changes to the Drilling and Production Regulations, the development of environmental policy for the production of oil from the oil sands, and to enable major projects in BC such as LNG development.
- 40. The Canadian Cancer Society, BC and Yukon is lobbying the Minister of Health, the Minister of Finance and the Minister of Labour to discuss cancer prevention policy opportunities and gaps in service for those living with cancer.
- 41. The Canadian Diabetes Association is lobbying the Minister of Health (and his staff) and a number of MLAs on a range of issues including expanding the current publicly funded insulin pump program and list diabetes medications with proven efficacy on the provincial drug formulary in a timely manner.
- 42. Canadian Natural Resources Limited is lobbying a number of public office holders on several issues including to ensure effective and efficient processes related to abandonment and reclamation of well sites/facilities, and to enhance regulatory efficiencies and ensure appropriate environmental outcomes related to oil and natural gas drilling and completion activities.
- 43. Canadian Pacific is lobbying a number of public office holders to provide the Canadian Pacific perspective on Federal transportation policy relevant to BC, and to provide information on Canadian Pacific emergency planning and response.
- 44. The Cannabis Commerce Association of Canada is lobbying several MLAs to ensure BC's Cannabis Act and any subsequent regulations that derive from it are inclusive of small businesses and the existing craft cannabis sector.
- 45. The Cement Association of Canada is lobbying an extensive list of public office holders on a number of issues including acceptance of alternative and renewable fuels for use in cement manufacturing, amendments to the carbon tax, and modifications to the *Wood First Act*.

- 46. Cenovus Energy Inc. is lobbying an extensive list of public office holders on a range of topics including the development of regulations with regard to emissions reductions, carbon tax expansion and methane reduction regulations, water management issues, and ensuring the oil and gas industry remains competitive and safe.
- 47. The Chamber of Shipping of British Columbia is lobbying several ministers on a number of issues including discussing opportunities to make BC ports more competitive, discussing shipping activities with respect to the need to further develop trade with Asian countries, and seeking support for shared messaging on the importance of shipping to BC and Canada.
- 48. Chevron Canada Limited Burnaby Refinery is lobbying MLAs to ensure the tax and environmental policy regimes are competitive for capital investment.
- 49. Cisco Systems Canada Co. is lobbying a number of public office holders seeking opportunities to compete for government contracts in communication and information technology.
- 50. CUPE BC is lobbying a number of public office holders to reinstate the BC Human Rights Commission, to seek improvements to worker's rights and to increase awareness of CUPE.
- 51. Enbridge Inc. is lobbying an extensive list of public office holders regarding Enbridge plans and operations in BC, including natural gas gathering, processing and transmission assets, and the impact of taxation on the fiscal and competitive environmental of the natural gas sector and the taxation of Enbridge operations.
- 52. Gateway Casinos & Entertainment Limited is lobbying a number of public office holders regarding rezoning of existing casino locations, discussions of gaming principles, and possible expansion of the company's operations.
- 53. GlaxoSmithKline is lobbying a number of public office holders to engage government staff on their product pipeline, secure listing for appropriate patients for their innovative medicines and vaccines and to discuss relevant policy issues.
- 54. Global Automakers of Canada is lobbying several public office holders on a number of issues including promoting various ways of achieving decarbonisation of transportation, and working with officials to ensure that evidence-based approach is used when adding products to designated lists for products stewardship programs.
- 55. IBM Canada Ltd is lobbying a number of public office holders to provide advice and recommendations to the government on policy approaches and instruments to advance BC's science, technology and innovation agenda.

- 56. Innovative Medicines Canada is lobbying a number of public office holders on a range of topics including facilitating "value demonstrating initiatives" partnerships in BC, the value of innovative medicines, and PharmaCare legislation, regulation and policy.
- 57. Investment Industry Regulatory Organization of Canada is lobbying a number of public office holders to seek amendments to the Securities Act.
- 58. Irosoft is lobbying staff of the Minister of Public Safety and Solicitor General to present their products for government to manage the life cycle of their legislative documents.
- 59. The Island Corridor Foundation is lobbying the Minister of Transportation and Infrastructure and MLA Sonia Furstenau (Cowichan Valley) to re-establish train service on Vancouver Island.
- 60. Kinder Morgan Canada Limited is lobbying staff of Ministry of Energy, Mines and Petroleum Resources regarding discussion and presentation of plans relating to the Trans Mountain Expansion Project.
- 61. The Mining Association of British Columbia is lobbying an extensive list of public office holders on a number of topics including support for revenue sharing, First Nations training initiatives, rural post-secondary training initiatives and institutions, and mining policies, regulations, legislation and permitting.
- 62. Norbord Inc. is lobbying several public office holders to obtain short and long term forest tenure in support of the continued operation of their 100 Mile House oriented strand board facility, and to encourage introduction or modification of legislation, regulation and/or policies to promote and enhance the engineered wood products industry.
- 63. The Real Property Association of Canada is lobbying staff of the Ministry of Energy, Mines and Petroleum Resources to influence the design of potential building energy and water reporting and disclosure requirements.
- 64. Rothmans, Benson, and Hedges is lobbying the Premier, the Minister of Finances, the Minister of Health and the Minister of Attorney General on issues relating to smoke-free alternatives including heated tobacco, vaporizers and electronic cigarettes.
- 65. Shell Canada Limited is lobbying several public office holders on LNG fiscal framework, LNG-related carbon management issues, LNG tax regulation, freehold production tax regulation, and changes to natural gas royalties.
- 66. Toyota Canada Inc. is lobbying a number of public office holders on a number of issues including climate change policies, advanced technology vehicles, and market alternative forms of transportation.

- 67. The Truck Loggers Association is lobbying the Premier and several Ministers on policies and regulations affecting their members engaged in forestry operations throughout BC, and for funding for the *Forest Service Providers Act* that will result in ongoing lien protection for forest service providers.
- 68. Woodside Energy International (Canada) Ltd. is lobbying a number of public office holders regarding energy and natural gas policy including taxes, royalties and other government revenues, regulatory issues, petroleum and natural gas tenure, electrical infrastructure and greenhouse gas emissions.
