## BC?

## **Monthly Snapshot – February 2020**

The following organizations and consultant lobbyists submitted their registrations under the B.C. Lobbyists Registration Act and they were activated between February 1 and February 29, 2020. Here is a brief summary of lobbying activities organizations and consultant lobbyists have or expect to carry out. BC Government and Service Employees' Union is lobbying a number of public office holders on a number of issues including improvements to postsecondary education, with funding increases and changes to trades training in BC, promoting the training, recruitment and retention of workers in the justice system and seeking support for strategies to address the housing affordability crisis in BC.

The BC Non-Profit Housing Association is lobbying several public office holders for the establishment of more affordable rental housing in BC and Canada, support for capacity and research tools for the non-profit sector, more support for low-income tenants, and the alleviation of homelessness through housing and supports.
- 46. The BC Salmon Farmers Association is lobbying several public office holders regarding a number of matters related to the salmon farming industry, including the Environmental Management Act and the Land Act, permitting decisions, and the Agrifood and Seafood Strategic Growth Plan.
- 47. The British Columbia Chiropractic Association is lobbying a number of public office holders to advocate for enhanced access to chiropractic services; chiropractors participating in team-based primary care; and chiropractor access to direct referral for publicly funded imaging as well as access to view electronic images.
- 48. The British Columbia Dental Hygienists' Association is lobbying the Minister of Health and a number of public office holders in the Ministry of Health with respect to updates to the Dental Hygiene Regulations and recommendations that have been made by government to amalgamate the four oral health colleges into one.
- 49. British Columbia Radiological Society is lobbying several public office holders regarding a provincial approach to managing diagnostic imaging.
- 50. The Chartered Professional Accountants of British Columbia (CPABC) is lobbying the Minister of Advanced Education, Skills and Training to seek amendments to the Chartered Professional Accountants Act.
- 51. The Canadian Urban Transit Research & Innovation Consortium is lobbying an extensive list of public office holders regarding a number of issues including: facilitation of a neutral feasibility assessment of H2 (Hydrogen) heavy duty vehicle performance throughout public fleets across British Columbia; additional electrification of systems via hydrogen fuel cell technologies and hydrogen production; funding for a data-based simulation and feasibility analysis of the performance of H2 heavy-duty vehicles and fuelling systems across mountainous terrain and four seasons of temperature gradient;

- and battery electric mobility, fuel cell electric mobility, smart autonomous and connected vehicle mobility, and data-driven mobility solutions.
- 52. The Confederation of University Faculty Associations of British Columbia (CUFA BC) is lobbying the Minister of Advanced Education, Skills and Training with respect to legislative changes to the Universities Act and the Royal Roads University Act, as well as matters related to university governance and provincial funding.
- 53. The D&B Companies of Canada ULC is lobbying staff of several public agencies to promote efficient and innovative government solutions through transparent and robust data analytics and modern IT infrastructure.

- 60. Genome British Columbia is lobbying a number of public office holders regarding provincial participation to expand BC-based genomic research and innovation initiatives.
- 61. The Health Sciences Association of BC is lobbying several public office holders on a number of issues including advocating for increased training spaces and opportunities for allied health professionals, increased funding for Early Intervention Therapy, and violence-prevention for workers in the health sector.

- 62. Hewlett Packard Enterprise Canada Co. is lobbying an extensive list of public agencies regarding HPE servers, networks, storage, software and related support.
- 63. JUUL Labs Canada is arranging meetings with several public office holders to raise awareness and provide communication with key government officials about JUUL Labs Inc. in British Columbia, particularly with regard to the development of policies related to vaping products.
- 64. Lime Technology Inc. is lobbying a number of public office holders regarding the development and establishment of the Motor Vehicle Act Pilot Project as it pertains to electric scooters and proposals received from local communities.
- 65. LNG Canada Development Inc. is lobbying several public office holders on a number of topics including engagement of Indigenous communities around resource development, economic growth and sustainable social opportunities; discussions on LNG fiscal framework, discussions on LNG-related carbon management issues, and updates on LNG Canada.
- 66. Mitacs Inc. is lobbying an extensive list of public office holders for support for their research internship programs for post-secondary students and post-doctoral fellows.
- 67. Ovintiv Canada ULC is lobbying an extensive list of public office holders on matters relating to liquids-rich natural gas and light, tight oil energy resource development, including access and infrastructure for resource development and associated activities; the regulatory framework for resource development including those related to operations, technical practices and liability management; consultation requirements; UNDRIP implementation; Environmental Assessment revitalization; Land & Resource Management Plans; Regional Strategic Environmental Assessment; Climate and Greenhouse Gas emissions policies; the fiscal framework for resource development; and Climate / Greenhouse Gas emissions / Low Carbon Industrial Strategy policies and programs.
- 68. Purdue Pharma (Canada) is lobbying staff of the Ministry of Health to advocate for the addition of one or more innovative medicines to the provincial formulary.
- 69. Rogers Communications Inc. is lobbying staff of a number of public agencies about contracts and policies related to the delivery of telecommunication services.
- 70. Sandoz Canada Inc. is lobbying a number of public office holders regarding various issues including public funding of pharmaceutical treatments developed, manufactured and supplied by Sandoz Canada; the regulatory environment and utilization rates for generics and biosimilars; and regulation of pharmacies in British Columbia to sell and distribute medical cannabis to patients.
- 71. Tides Canada Initiatives Society is lobbying a number of public office holders on a range of issues related to watershed governance and freshwater monitoring and protection in BC.

- 72. TRIUMF is lobbying a number of public office holders regarding TRIUMF's activities across its program areas, with a particular focus on opportunities related to medical isotopes, data science and quantum materials.
- 73. The United Food and Commercial Workers Local 1518 is arranging meetings with the Minister of Labour to discuss the gig economy and the changing labour market.
- 74. Vancouver City Savings Credit Union (Vancity) is lobbying a number of public office holders to discuss options for government support in the relocation of Pigeon Park Savings, and the future of the credit union system in BC including changes to legislation, and establishment of rules and regulations to support the *BC Financial Institutions Act*.
- 75. West Fraser Timber Co. Ltd. is lobbying a number of public office holders on a range of issues including potential bioenergy and natural gas electricity sales agreements, timber sales, timber tenure reform and pricing formulae and discussions regarding Bill 22.
- 76. The Wilderness Tourism Association of BC is lobbying a number of public office holders regarding administrative and resource management activities that affect tourism, tourism tenures, tourism opportunities, with the primary focus on forestry, lands and parks management.

Woodfibre LNG Limited is arranging meetings with a number of ministers on a range of topics including partnerships and reconciliation with First Nations; aligning education programs with LNG industry needs for a skilled domestic workforce; environmental stewardship of forests, fisheries, wildlife and water resources; discussion of climate change issues and environmental assessment reviews; and taxation and assessment processes at the municipal and regional level.
