

WHO'S LOBBYING WHO IN BC? Monthly Snapshot – October 2021

The following is a brief summary of new Registration Returns activated or re-activated between October 1 and October 31, 2021 under BC's *Lobbyist Transparency Act*.

- Bill Anderson, a consultant lobbyist with Crestview Strategies, is lobbying public office holders in several public agencies on behalf of Intact Financial Corporation in order to engage the provincial government on climate change adaption as it relates to extreme weather, in addition to personal, property, and commercial insurance products.
- 2. Bill Anderson, a consultant lobbyist with Crestview Strategies, is lobbying public office holders in several public agencies on behalf of PointsBet Canada Operation 1 Inc. in regard to single-event sports betting and associated economic impacts.
- 3. Bill Anderson, a consultant lobbyist with Crestview Strategies, is lobbying public office holders in several public agencies on behalf of Riipen Networks Inc. to expand work integrated learning and deliver job and skills learning opportunities for all ages across British Columbia.
- 4. Jeff Andrus, a consultant lobbyist with Strategies 360 Canada, is lobbying public office holders in several public agencies on behalf of Pembina Pipeline Corporation including discussions and updates regarding Pembina's projects in BC, including the Prince Rupert export terminal, BC's energy, environmental and climate change policies as well as BC's environmental assessment processes;

Placements Vanguard Canada Inc. in regard to policies and program recommendations impacting investments in investment products including mutual funds and exchange traded funds.

Leila Farmer, a consultant lobbyist with Global Public Affairs Inc. is lobbying public office holders in several public agencies on behalf of Canada Fortescue Future Industries Ltd. with respect to the ongoing development of BC Hydrogen strategy to secure an investment client for Fortescue Future Industries.

- 27. British Columbia Association of Broadcasters is lobbying public office holders in several public agencies regarding COVID-19 economic relief measures, which could include tax measures or guaranteed advertising agreements.
- 28. British Columbia Sports Hall of Fame and Museum is lobbying public office holders in several public agencies with respect to sport and reconciliation initiatives, inclusion of museums in public health orders related to COVID-19 and COVID-19 business resilience and recovery funding.

- 29. Building Owners and Managers Association of British Columbia is lobbying public office holders in several public agencies in regard to education and certification of commercial building operators and property managers and a fair commercial property tax structure.
- 30. Canadian Internet Registration Authority is lobbying public office holders in several public agencies in regard to the development of BC led programs to improve data security and cyber security in public sector organizations and participate in broadband funding programs with a view to integrate CIRA broadband data into broadband mapping and validation processes.
- 31. Canadian Men's Health Foundation is lobbying public office holders in several public agencies to seek funding and discuss men's health initiatives aimed at changing men's behaviour to address gaps in health care.
- 32. HumanisRx Corporation is lobbying public office holders in several public agencies in regard to the use of proprietary software to expand the application of clinical pharmacology in primary health care and post secondary institutions pharmacist training in the use of proprietary software in the practice of clinical pharmacology.
- 33. Kamloops Thompson Teachers' Association is lobbying public office holders in several public agencies regarding matters including curriculum changes; funding for public education; additional school buildings and upgrades, COVID 19 effects on teaching and learning in schools; implementing the call to action of the Truth and Reconciliation Commission of Canada; elimination of Foundation Skills Assessment and recruitment and retention issues with teachers.
- 34. Labatt Breweries of Canada is lobbying public office holders in several public agencies regarding matters including policy changes to taxation, delivery, and manufacturing location as it applies to beer, cider and ready-to-drink products in BC, as well as post COVID Tourism grant opportunities.
- 35. License Plates of Texas LLC is lobbying public office holders in several public agencies to provide additional license plate options to British Columbia drivers.
- 36. LiUNA Local 1611 is lobbying public office holders in several public agencies with respect to the Community Benefits Agreements and the Labour Code.
- 37. LlamaZOO Interactive Inc. is lobbying public office holders in several public agencies with respect to LlamaZOO's technology and to seek funding and discuss potential projects with an extractive industry focus, including the application of 3D visualization to the Environmental Assessment process.
- 38. Teamsters Local Union No. 213 is lobbying public office holders in several public agencies in regard to the changes of Community Benefits Agreements and the Labour Code.

39. West Kelowna Professional Firefighters are lobbying public office holders at the Ministry of Citizens' Services and Ministry of Health to advocate for changes in the Workers Compensation Act of British Columbia to amend latency periods related to cancers experienced by firefighters.
