

WHO'S LOBBYING WHO IN BC? Monthly Snapshot – December 2021

The following is a brief summary of new Registration Returns activated or re-activated between December 1 and December 31, 2021 under BC's *Lobbyists Transparency Act*.

- Bill Anderson, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of Holland America Group regarding the economic impact of Covid-19 on the cruise ship industry and tourism sector.
- Bill Anderson, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of S.C. Johnson & Son Inc. regarding the CleanBC Plastic Action Plan to ensure intended product usage is considered in future regulations from the province.
- 3. Bill Anderson, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of SkipTheDishes Restaurant Services Inc. with respect to the food delivery application business model and the role it plays in supporting restaurants and businesses, especially in light of the state of emergency, physical distancing requirements and essential workplaces list.

- 6. Kevin Bosch and Naresh Raghubeer, consultant lobbyists with Sandstone Group, are lobbying public office holders at several public agencies on behalf of Grieg Seafood B.C. Ltd to advocate on the promotion of Grieg Seafood's positive contribution to Salmon Farming in BC and Canada including jobs, investments, economic reconciliation with Indigenous communities, current and future licences and investments.
- 7. Dennis Burnside, a consultant lobbyist with Capital Hill Group, is lobbying public office holders at several public agencies on behalf of VinFast Auto Canada Inc. regarding matters including advocacy on Battery as a Service model (BaaS) within Clean BC's Go Electric and Clean BC's Roadmap programs as well as VinFast stakeholder process related to Electric Vehicle roll out and availability in BC.
- 8. Peter Cleary and Patil Imsadounian, consultant lobbyists with Santis Health Inc., are lobbying public office holders at several public agencies on behalf of Crisis Intervention and Suicide Prevention Centre of British Columbia regarding policy and program recommendations on the development of a full Crisis Care Continuum based in community with seamless referral to psychiatric resources and access to police resources as appropriate.
- Michael Cunningham, a consultant lobbyist with Graphite Public Affairs, is lobbying public office holders at several public agencies on behalf of DoorDash Technologies Canada Inc. regarding engagement and advocacy related to food delivery services and policies impacting commissions and service delivery fees.

Maeghan Dewar, a consultant lobbyist with Longview Communications Inc, is lobbying public office holders at several public agencies on behalf of Taseko Mines Limited regarding matters including legislation, regulations, policies and programs on mine permitting, climate action and compliance and enforcement matters relevant to mineral investment and safe, environmentally sound and socially responsible operations of mining in BC as well as to engage government with respect to Taseko's relations with First Nations groups in BC such as consultation, employment, contracting and other economic opportunities, partnerships and agreements and related reconciliation activities.
- 11. James Hoggan, a consultant lobbyist with Hoggan & Associates, is lobbying public office holders at the Ministry of Environment and Climate Change Strategy on behalf of Harmony Foundation of

Canada in regard to the recommendations contained in The Great Caribou Rainforest Conservation Area proposal.

- 12. Bradley Lavigne, a consultant lobbyist with Counsel Public Affairs Inc., is lobbying public office holders at several public agencies on behalf of Vopak Development Canada Inc. in regard to Vopak Pacific Canada Liquid Bulk Export and Storage Terminal Road, Rail & Utility Corridor Expansion Project in Prince Rupert.

Kevin Mason, a consultant lobbyist with FleishmanHillard HighRoad, is lobbying public office holders at several public agencies on behalf of Premiere Packaging Services Inc (dba: Medallion Milk) in regard to provincial procurement opportunities for Medallion Milk's premium milk products and socialize their overarching value proposition to government stakeholders.

Rachel McLaughlin, a consultant lobbyist with PAA Advisory | Conseils, is lobbying public office holders at several public agencies on behalf of Visa Canada Corporation in regard to advancing issues related to the payments industry including electronic payments, consumer protection, and small merchant concerns.
- 15. Kyle Olsen, a consultant lobbyist with Olsen+Biggs Public Affairs, is lobbying public office holders at the Ministry of Health on behalf of Rapid Medical Supplies LLC in regard to the sale of Covid-19 tests, treatments and PPE.
- 16. Ben Parsons, a consultant lobbyist with Counsel Public Affairs Inc., is lobbying public office holders at several public agencies on behalf of Emergent BioSolutions Canada Inc. with respect to increasing access to publicly funding NARCAN[®] (Naloxone HCI) Nasal Spray.
- 17. Paul Sullivan, a consultant lobbyist with Ryan ULC, is lobbying public office holders at several public agencies on behalf of Business Tax Alliance to advocate on Small Business Property Tax Fairness.
- 18. Bill Tieleman, a consultant lobbyist with West Star Communications, is lobbying public office holders at several public agencies on behalf of Queen Charlotte Lodge Ltd. in regard to health and safety regulations during the COVID-19 situation for tourism operations in remote locations.
- 19. Gurpreet Vinning, a consultant lobbyist with Prospectus Associates, is lobbying public office holders at several public agencies on behalf of Shift Clean Solutions Ltd. in regard to the government's focus on CleanBC2030 and the decarbonization of marine industries, encouraging the development of battery powered clean energy solutions within the BC Transportation industry.
- 20. The Arthritis Research Centre Society of Canada is lobbying public office holders at the Ministry of Health for funding.

- 21. The B.C. Wildlife Federation, is lobbying public office holders at several public agencies regarding matters including regulation and policy recommendations to ensure safe firearms use related to rifle ranges, hunting, trapping and recreational firearms use; legislation, regulation, policy changes and funding to support habitat, fish and wildlife conservation ; and advocating for public access to public resources including activities such as berry picking, hiking, camping, hunting and fishing.
- 22. Canadian Union of Public Employees, Local 723 is lobbying public office holders at several public agencies in regard to advocating for a public universal childcare system and expansion of child care services as well as funding for a public universal childcare system and delivery of school aged childcare integrated with the public education system.
- 23. Chimo Community Services Society is lobbying public office holders at several public agencies in regard to promoting the continuation of Chimo Crisis Line services and the development of a full Crisis Care Continuum based in community with seamless referral to psychiatric resources and access to police resources as appropriate.
- 24. Construction Maintenance and Allied Workers Canada is lobbying public office holders at several public agencies in regard to funding for Community Benefit Agreements or Project Labour Agreements for anticipated construction projects within the province.
- 25. Community-Based Research Centre Society is lobbying public office holders at several public agencies in regard to improving two-Spirit, queer and trans health outcomes.
- 26. Doordash Inc. is lobbying public office holders at several public agencies regarding engagement and advocacy related to food delivery services and policies impacting commissions and service delivery fees.
- 27. Domtar Inc. is lobbying public office holders at several public agencies regarding policy and program recommendations on carbon pricing programs; utilizing under-utilized fiber in BC; and funding for operator training.
- 28. Ducks Unlimited Canada is lobbying public office holders at several public agencies on a number of issues including enhancing wetland conservation in BC through planning and regulatory measures, and aligning policy and the regulatory environment with the needs of conservation.
- 29. J-SAS Inc. is lobbying public office holders at the Ministry of Municipal Affairs in regard to creating a province-wide, shared-service lobbyist registry system for BC Municipalities.

- 30. Kelowna Community Resources Society is lobbying public office holders at several public agencies seeking funding to fill gaps in service for those in need, and advocating to modify programs to best meet community need.
- 31. North Coal Ltd. is lobbying public office holders at several public agencies in regard to Canadian steelmaking coal in the decarbonisation of the global steel industry, water management including the Elk Valley Water Quality Plan, and clarity and development of indigenous reconciliation in reference to natural resource projects.
- 32. Okanagan Boys and Girls Clubs is lobbying public office holders at several public agencies in regard to the transition of child care to the Ministry of Education as well as the principles, objectives and plans within the newly signed bilateral child care agreement.
- 33. Options Community Services is lobbying public office holders at several public agencies to advocate for existing crisis line services and stop the request for proposal tendering process before it commences and/or that direct awards are issued for existing providers.
- 34. Palantir Technologies Canada Inc., is lobbying public office holders at several public agencies in regard to improving patient care while optimizing limited health system resources match needs and objectives of the BC public health system.
- 35. United Steelworkers, is lobbying public office holders at several public agencies regarding matters including the stay of proceedings in the case of Sam Fitzpatrick's workplace death, to call on the Attorney General to reinstate the proceedings under the Criminal code, implement the recommendations from the Lisa Helps report to improve work safety, and implement recommendations of the BCFED submission in response to the Ministry of Labour's Keeping Workers, the Public and Environment Sage from Asbestos report.
