

WHO'S LOBBYING WHO IN BC? Monthly Snapshot – January 2022

The following is a brief summary of new Registration Returns activated or re-activated between January 1 and January 31, 2022 under BC's *Lobbyists Transparency Act*.

- Dennis Chan, a consultant lobbyist with Pathway Strategies Inc., is lobbying public office holders at several public agencies on behalf of Vertex Pharmaceuticals (Canada) Inc. regarding the public reimbursement of patients by the Ministry of Health for the client's medicines treating cystic fibrosis.
- Maeghan Dewar, a consultant lobbyist with Longview Communications Inc., is lobbying public office holders at several public agencies on behalf of Paper Excellence Canada Holdings Corporation in regard to support in response to Covid-19 and assistance in securing fibre for pulp operations; negotiations around expiring Energy Purchase Agreements.
- 3. Nathan Dudley and Ian Murray, consultant lobbyists with Ian Murry & Company are lobbying public office holders at several public agencies on behalf of Air Products Canada Ltd. regarding matters including regulations relating to C02 production and reduction; hydrogen, emissions reductions and carbon capture processing technologies; Greenhouse Gas rules and their impact on their-party producers and sellers of hydrogen; and policies and programs that encourage the production and use of hydrogen as an alternative source of fuel.

- 4. Allan Krasnick, a consultant lobbyist with Allan Krasnick & Co., is lobbying public office holders at the Ministry of Indigenous Relations and Reconciliation on behalf of Dandzen Development LP in relation to creating an intellectual property repository and converting the Tsilhqot'in fleet of vehicles to allelectric.
- 5. Anna Lilly, a consultant lobbyist with FleishmanHillard HighRoad, is lobbying public office holders at several public agencies on behalf of Canadian Media Producers Association BC Branch in regard to improving opportunities for equity-seeking producers in BC; insurance solutions for Film and Television sector; the designation of national funding; tax credits, and funding for Creative BC; and the Federal Emergency Relief Fund and funding through Creative BC.
- 6. Jean-Marc Prevost, a consultant lobbyist with Counsel Public Affairs Inc., is lobbying public office holders at several public agencies on behalf of Vopak Development Canada Inc. in regard to Vopak Pacific Canada Liquid Bulk Export and Storage Terminal Road, and Rail & Utility Corridor Expansion Project in Prince Rupert.
- Naresh Raghubeer, a consultant lobbyist with Sandstone Group, is lobbying public office holders at several public agencies on behalf of AMPD Ventures Inc. in regard to funding in the fields of innovation and technology, and IT infrastructure in British Columbia.
- 8. Moe Sihota, a consultant lobbyist with Parhar Investments & Consulting Ltd. is lobbying public office holders on behalf of Peak Renewables Ltd in regard to financial assistance to upgrade the railroad between Fort Nelson and Fort St. John and to establish policies for the efficient movement of fibre to production facilities and market.
- 9. Kevin Tetreault, a consultant lobbyist with Edelman Public Relations Worldwide Canada, is lobbying public office holders at several public agencies on behalf of Oracle Canada ULC in regard to solutions offered through Oracle Cloud Infrastructure to host old, legacy applications or introduce new ones to the ministries.
- 10. Matt Williamson, a consultant lobbyist with Global Public Affairs, is lobbying public office holders at several public agencies on behalf of Great Canadian Railtour Company Ltd. in regard to economic restart and recovery of the British Columbia tourism sector post-COVID-19 and current and future funding support options for tourism businesses severely impacted by COVID-19.
- 11. Air Products Canada Ltd. is lobbying public office holders at several public agencies regarding matters including regulations relating to CO2 production and reduction; hydrogen, emissions reductions and carbon capture processing technologies; Greenhouse Gas rules and their impact on third-party

producers and sellers of hydrogen; and policies and programs that encourage the production and use of hydrogen as an alternative source of fuel.

- 12. Apple Canada Inc. is lobbying public office holders at the Ministry of Citizens' Services regarding information technology solutions, the utilization of Apple products and services, and accessibility solutions involving Apple products.
- 13. Canadian Institute for Advanced Research (CIFAR) is lobbying public office holders at several public agencies to seek funding for long-term collaborative research projects in CIFAR's 13 fields of research, including health, society, advanced technologies and COVID-19.
- 14. Canadian Institute for Climate Choices is lobbying public office holders at several public agencies regarding changes to environmental and climate change policy.
- 15. The Canadian Vaping Association is lobbying public office holders at several public agencies regarding E-Substance regulation under the Public Health Act, with topics including flavours, nicotine concentrations, labelling and packaging, and taxation.
- 16. Great Canadian Railtour Company Ltd. is lobbying public office holders at several public agencies regarding policy and planning priorities, including economic restart and recovery of the British Columbia tourism sector post-Covid-19 as well as funding for tourism business severely impacted by Covid-19.
- 17. Grieg Seafood B.C. Ltd is lobbying public office holders at several public agencies in regard to the promotion of Grieg Seafood's positive contribution to Salmon Farming in BC, including jobs, investments, economic reconciliation with Indigenous communities, current and future licenses and investments.
- 18. HumanisRx Corporation is lobbying public office holders at several public agencies in regard to the use of proprietary software to expand the application of clinical pharmacology in primary health care and pose secondary institutions pharmacist training in the use of proprietary software in the practice of clinical pharmacology.
- 19. Kyndryl Canada Limited is lobbying public office holders at the Ministry of Citizens' Services in regard to investments in Kyndryl systems and services.
- 20. National Elevator and Escalator Association is lobbying public office holders at several public agencies in regard to the built environment and ensuring that there are adequate transportation systems in buildings.

- 21. Net Zero Solutions Business Roundtable is lobbying public office holders at several public agencies in regard to implementation of the CleanBC climate plan and development of BC's economic strategy.
- 22. Open Mind Developments Corporation is lobbying public office holders at several public agencies regarding matters including advocating for a consumer rebate for technology solutions which reduce carbon emissions, food waste and/or expenses to municipal governments; funding for Lomi by Pela demonstration projects with municipal governments in Canada; and pursuing procurement opportunities for Lomi product.
- 23. Parrish & Heimbecker, Limited is lobbying public office holders at several public agencies in regard to financial support in the form of carbon credits for a new project related to the Fraser River.
- 24. Wal-Mart Canada Corp. is lobbying public office holders at several public agencies in regard to supply chain issues, including transportation, and the Province's goals for influenza vaccinations and Province-wide distribution of the influenza vaccine.
