

WHO'S LOBBYING WHO IN BC? Monthly Snapshot – February 2022

The following is a brief summary of new Registration Returns activated or re-activated between February 1 and February 28, 2022 under BC's *Lobbyists Transparency Act*.

- Timothy Agg, a consultant lobbyist, is lobbying public office holders at several public agencies on behalf of QMUNITY BC's Queer, Trans and Two-Spirit Resource Centre Society seeking funding from a variety of government sources in support of the social services provided by QMUNITY, and seeking funding increase to a youth services contract with the Ministry of Children and Family Development.
- Bill Anderson, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of Peloton Interactive Inc. in regard to public policy and programs that support the health and wellness of British Columbians, protect data privacy and support economic development.
- Karamveer Bal and Dennis Chan, consultant lobbyists with Pathway Strategies Inc., are lobbying
 public office holders at several public agencies on behalf of Merck Canada Inc. in regard to conditions
 under which innovative drugs, vaccines or other therapies are reimbursed or otherwise funded
 publicly in BC.

- 4. Karamveer Bal and Dennis Chan, consultant lobbyists with Pathway Strategies Inc. are lobbying public office holders at several public agencies on behalf of Hoffman-La Roche Limited in regard to potential public reimbursement models and policies for the client's medicines.
- 5. Emilio Caputo, a consultant lobbyist with Global Public Affairs Inc. is lobbying public office holders at several public agencies on behalf of Fire & Flood Emergency Services Ltd. in regard to procurement opportunities for their fire and flood prevention, training and response services.
- 6. Nathan Dudley and Richard Stout, consultant lobbyists with Ian Murray & Company Ltd., are lobbying public office holders at several public agencies on behalf of Canadian Council for Sustainable Aviation Fuels in regard to policies that promote the possibilities of deploying sustainable aviation fuels in BC, funding studies for the production of sustainable fuel and to ensure national standards to be complementary to the internal criteria in terms of low carbon intensity for aviation fuels.
- 7. Lise Fenton, a consultant lobbyist with Strategies 360 Canada, is lobbying public office holders at several public agencies on behalf of Professional Employees Association in regard to improvement of public sector professionals work environment, employment terms and conditions and increased staffing levels.
- 8. Andrew House, a consultant lobbyist with Fasken Martineau DuMoulin LLP, is lobbying public office holders at several public agencies on behalf of 1761595 Alberta Ltd. regarding equitable access to lake docks for upland owners in Shuswap.
- 9. Mark Jiles and Rob Nagai, consultant lobbyists with Bluestone Government Relations, are lobbying public office holders at several public agencies on behalf of Ecowaste Industries Ltd. regarding a change to the Agricultural Land Use Regulation, and work within the Environmental Management Act and the Agricultural Land Reserve Act so EMA is able to make a unilateral decision to support a landfill approval over and above the ALC Act.
- 10. Mark Jiles and Rob Nagai, consultant lobbyists with Bluestone Government Relations, are lobbying public office holders at Ministry of Environment and Climate Change Strategy on behalf of South Street Development Group to advocate for an environmental approval for a development application.
- 11. Anna Lilly, a consultant lobbyist with FleishmanHillard HighRoad, is lobbying public office holders at several public agencies on behalf of Wal-Mart Canada Corp. in regard to supply chain and transportation, as well as influenza vaccinations and province wide distribution of the influenza vaccine.

- 12. Alex McMillan, a consultant lobbyist with McMillan Solutions, is lobbying public office holders at several public agencies on behalf of BC Chamber of Commerce in regard to government's participation in celebrating BC Chamber of Commerce Week and advocacy related to Covid-19 support and the need for the government to provide assistance to impacted businesses.
- 13. John Moonen, a consultant lobbyist with John Moonen & Associations Ltd., is lobbying public office holders at several public agencies on behalf of Champ's Fresh Farms Inc. regarding government implementation of various environmental and land use statutes and regulations including the Environmental Managements Act, the Code of Practice for Agricultural Environmental Management and other laws and regulations affection mushroom production.
- 14. Kyle Olsen, a consultant lobbyist with Olsen+Biggs Public Affairs, is lobbying public office holders at the Ministry of Health on behalf of 8ieme Sens Inc. to advocate regarding the direct purchase of Covid-19 rapid tests by the government of BC.
- 15. Dennis Rogoza, a consultant lobbyist with Rogoza Consulting Group Inc., is lobbying public office holders at several public agencies on behalf of Parrish & Heimbecker, Limited seeking support from Ministries for the expansion of the grain terminal in Surrey BC.
- 16. Ishwari Sawant, a consultant lobbyist with Crestview Strategy Inc., is lobbying public office holders at several public agencies on behalf of Entertainment One Canada Ltd. in regard to proposed amendment to the British Columbia film and television production services tax credit.
- 17. Richard Stout, a consultant lobbyist with Ian Murray & Company Ltd., is lobbying public office holders at several public agencies on behalf of Air Products Canada Ltd. in regard to the development of BC government programs, legislation, support or funding awards for the development of facilities to produce and distribute clean hydrogen energy within BC.
- 18. Scott Takenaka, a consultant lobbyist with Global Public Affairs, is lobbying public office holders at the Ministry of Transportation and Infrastructure on behalf of Vancouver Airport Authority in regard to areas of alignment and discuss partnerships between government and Vancouver Airport Authority with respect to Vancouver Airport Authority's 2022 Strategic Plan and Land Use Plan.
- 19. Darryl Tempest, a consultant lobbyist, is lobbying public office holders at the Ministry of Health on behalf of The Canadian Vaping Association regarding vaping regulatory changes for labeling and product design standards.
- 20. Bill Tieleman, a consultant lobbyist with West Star Communications, is lobbying public office holders at several public agencies on behalf of CIRP Construction Industry Rehabilitation Plan Inc. in relation

- to reducing deaths, illnesses and loss of employment in the construction industry due to the opioid overdose crisis, substance abuse and mental health issues, and improving rehabilitation services for construction workers.
- 21. Gurpreet Vinning, a consultant lobbyist with Prospectus Associates, is lobbying public office holders at several public agencies on behalf of FortisBC Energy Inc. with respect to the development of the Green House Gas Reduction and policy development of Clean BC 2030.
- 22. Matt Williamson, a consultant lobbyist with Global Public Affairs, is lobbying public office holders at several public agencies on behalf of Fire & Flood Emergency Services Ltd. regarding BC government procurement opportunities for their fire and flood prevention, training and response services.
- 23. British Columbia Cattlemen's Association is lobbying public office holders at several public agencies regarding matters including changes to wildlife management that includes apex predators; policy recommendations to Forest Practices Act and Livestock Water regulations under Water Sustainability Act; recommend changes to the application process for the licensing of ground water under the Water Sustainability Act; and to develop programs and funding to allow for more water to be stored on private and Crown Lands as well as funding for the development of a beef processing facility.
- 24. British Columbia Co-operative Association is lobbying public office holders at several public agencies in regard to changes to the Cooperative Associations Act and associated regulations, taxation and policy measures to ensure co-operatives have access to benefits provided to other business in a fair and equitable manner as well as to develop a long-term strategy for co-op growth and development, in particular as it relates to enterprises, child care and housing.
- 25. Canada Workday ULC is lobbying public office holders at several public agencies to advocate the government to utilize Workday Limited software and Canada Workday ULC's professional services.
- 26. Coast to Coast Holding Ltd. is lobbying public office holders at several public agencies to advocate for changes to the 2022 lease renewal and management of the Whistler Municipal Heliport.
- 27. DIVERSEcity Community Resources Society is lobbying public office holders at several public agencies with respect to matters including funding supports for MOSIAC, Career Paths program, Happipad & BGM Strategy group proposal, National Anti-Racism proposal and BC Refugees Readiness Fund.
- 28. Garda Canada Security Corporation is lobbying public office holders at the Ministry of Public Safety & Solicitor General advocating for the outsourcing of nonessential and/or administrative services currently provided by police forces to private security providers; seeking the awarding of private security contracts.

29. Surespan Construction Ltd. is lobbying public office holders at several public agencies to advocate for the use of pre-cast concrete to build additions for schools, fabricated pre-cast concrete as a solution for temporary housing structures for the homeless, and to identify new projects related to road and bridges.
