

## WHO'S LOBBYING WHO IN BC? Monthly Snapshot – June 2022

The following is a brief summary of new Registration Returns activated or re-activated between June 1 and June 30, 2022 under BC's *Lobbyists Transparency Act*.

- Jeff Andrus and Craig Keating, consultant lobbyists with Strategies 360 Canada, are lobbying public
  office holders at the Ministry of Health and the Ministry of Mental Health and Addictions on behalf of
  Strata Health Solutions Inc. advocating for the use of end-to-end health care referral software.
- 2. Ana Boskovic and Romina Moradi, consultant lobbyists, are lobbying public office holders at several public agencies on behalf of The British Columbia College of Family Physicians (A Chapter of The College of Family Physicians Of Canada) in regard to improvements that need to be made to better support family doctors, so that family doctors can continue to provide care British Columbians need and deserve.
- Sunny Cohen, a consultant lobbyist with Dentons Canada LLP, is lobbying public office holders at the Ministry of Finance and the Ministry of Jobs, Economic Recovery and Innovation on behalf of 1021823 BC Ltd. (OneWeb Canada) regarding rural and remote broadband connectivity in BC and broadband funding policy.

Len Flint and Ray Parks, consultant lobbyists with Ian Murray and Company Ltd., are lobbying public office holders at several public agencies on behalf of Canadian Council for Sustainable Aviation Fuels regarding policies that promote the possibilities of deploying sustainable aviation fuels in BC and to ensure complementarity with the international standards that are destined to exist, including low carbon intensity for aviation fuels.
- 7. Ujwal Ganguly, a consultant lobbyist with Temple Scott Associates, is lobbying public office holders at the Ministry of Finance on behalf of Mastercard Canada in regard to Mastercard's data and insights, cyber and intelligence, ID management and payment solutions capabilities.
- 8. Michael Gardiner, a consultant lobbyist with Strategies 360 Canada, is lobbying public office holders at several public agencies on behalf of FS Insurance Brokers, Inc. seeking strata insurance brokering rules and regulations that are fair and transparent and that protect choice and service quality.
- 9. Lynne Hamilton, a consultant lobbyist with Local Consultants Inc., is lobbying public office holders at several public agencies on behalf of Liquid River Capital Corp. in regard to funding for transportation, tourism and economic development initiatives.
- 10. Patrick Harris, a consultant lobbyist with OnGaming Canada Inc., is lobbying public office holders at several public agencies on behalf of BetMGM LLC in regard to the regulation of internet gaming and sports betting in the province of BC.
- 11. Meredith James, a consultant lobbyist with Woodward & Company Lawyers LLP, is lobbying Members of BC Legislative Assembly on behalf of Tsartlip First Nation in regard to the redevelopment of the Woodwynn Farm Site.
- 12. T.J. Keil, a consultant lobbyist with Counsel Public Affairs, is lobbying public office holders at the Ministry of Mental Health and Addictions on behalf of OpenCircle National Advocacy Ltd. regarding government and private sector programs to support mental health and safety in the workplace, and highlight OpenCircle's mental health initiatives to educate and support their members.

Dennis Marsden, a consultant lobbyist with Bluestone Government Relations is lobbying public office holders at BC Assessment Authority and the Ministry of Finance on behalf of BentallGreenOak (Canada) Limited Partnership to discuss the property assessment process and discuss ways to make a more equitable property tax distribution process through the implementation of new ways to address the highest and best use of a properties' value.
- 14. John Moonen, a consultant lobbyist with John Moonen & Associates Ltd. is lobbying public office holders at several public agencies on behalf of Heppell's Potato Corp. advocating for the need to preserve a parcel of farmland for agriculture and pressing for inclusion of the parcel in the ALR.
- 15. Ray Parks, a consultant lobbyist with IMC Projects, is lobbying public office holders at several public agencies on behalf of Air Products Canada Ltd. regarding regulations relating to CO2 production and reduction; hydrogen, emissions reductions, including carbon capture processing technologies; Greenhouse Gas rules and their impact on third-party producers and sellers of hydrogen; and policies and programs that encourage the production and use of hydrogen as an alternative source of fuel, including hydrogen produced by alternative processes and the purchased and retrofit of third-party facilities.

Jean-Marc Prevost, a consultant lobbyist with Counsel Public Affairs Inc., is lobbying public office olders at several public agencies on behalf of Innovative Medicines Canada in regard to health research partnerships with the BC government that support the growth and evolution of BC's health research system and life sciences sector.
- 17. Supreena Sekhon, a consultant lobbyist with Crest View Strategy Inc. is lobbying public office holders at the Ministry of Public Safety and Solicitor General on behalf of SMART Financial Operations LLC to advocate the critical role pawn brokers play in offering financial inclusion and access for British Columbians who are underserved by banks.

Katie Shaw, a consultant lobbyist with Earnscliffe Strategy Group, is lobbying public office holders at several public agencies on behalf of ACCIONA Infrastructure Canada Inc. in regard to environmental, social and governance (ESG) framework as it relates to support ESG principals for public infrastructure projects in BC.

Katie Shaw, a consultant lobbyist with Earnscliffe Strategy Group, is lobbying public office holders at several public agencies on behalf of Canadian Cancer Society in regard to the Canada Healthy transfer and stability of cancer care services, settle tobacco health care cost recovery lawsuits and any settlement measures to reduce tobacco use.

Katie Shaw, a consultant lobbyist with Earnscliffe Strategy Group, is lobbying public office holders at several public agencies on behalf of the Construction Foundation of BC (2012) Society to collaborate on applied research for building skilled trades, growing inclusion and retaining equity groups in the skilled trades and delivering programs to meet skilled trades shortages for specific sectors in the province and to advocate on the kelp industry and its relationship with First Nations communities for workforce development.
- 21. Chris Tollefson, a consultant lobbyist with Tollefson Law Corporation, is lobbying public office holders at several public agencies on behalf of Heiltsuk Tribal Council in regard to the repatriation and remediation of Crown lands subject to Aboriginal Rights and Title.
- 22. Darren Young, a consultant lobbyist with Ernst & Young, is lobbying public office holders at the Ministry of Energy, Mines and Low Carbon Innovation on behalf of Squamish Huron Clean Energy Corporation in pursuit of government funding.
- 23. BetMGM LLC is lobbying public office holders at several public agencies in regard to the regulation of internet gaming and sports betting in the province of BC.
- 24. Canadian News Media Association (DBA: News Media Canada) is lobbying public office holders at several public agencies regarding exempting newspapers from extended producer responsibility fees.
- 25. Comox District Teachers' Association is lobbying public office holders at several public agencies regarding funding of education including funding models.
- 26. Dapper Labs Inc. is lobbying public office holders at several public agencies in regard to the creation of a transparent and accountable regulatory framework for NFT digital collectibles that allows for market competition, innovation, and consumer protection while contributing to the growth and diversification of BC.
- 27. Greater Langley Chamber of Commerce is lobbying public office holders at several public agencies regarding matters including advocacy relating to crime and the impacts of prolific offenders on the business community; and changes to the Employments Standards Act and the Employer Health Tax.
- 28. Heppell's Potato Corp. is lobbying public office holders at the Ministry of Agriculture, Food and Fisheries regarding inclusion of the parcel of farmland into the Agricultural Land Reserve.
- 29. Private Forest Landowners Association is lobbying public office holders at several public agencies regarding matters including Managed Forest Land assessment and taxation, processes on Management Forest Private lands, Managed Forest Review and other environmental reviews and the promotion of fair economic opportunities for private forest landowners.

- 30. Red House Solutions Ltd. is lobbying public office holders at the Ministry of Attorney General and Minister responsible for Housing regarding changes to modernizing debt financing and aligning it to peer organizations to assist not for profits build more housing.
- 31. Resource Works Society is lobbying public office holders at several public agencies regarding ways of finding economic and environmental balance and the opportunity for made-in-BC innovation to become more influential in global trade.
- 32. Rio Tinto Alcan Inc. is lobbying public office holders at a number of public agencies with respect to a variety of matters including climate change initiatives and policy; policy recommendations on aluminum sector; environment regulations; programs aimed to advance Indigenous reconciliation; funding of the expansion of cellphone connectivity; Watershed Engagement Initiative for the Nechako Reservoir and the Watershed Security Strategy; employee and labour considerations; and workplace health and safety.
- 33. SNC-Lavalin Group Inc. is lobbying public office holders at several public agencies regarding aligning existing relationships with BC First Nations to government priorities and reconciliation initiatives; aligning on changes and trends related to BC Community Relations, environment, social and governance, and sustainability rules and regulations in BC; capabilities in hydro electricity and liquified natural gas project development; future Economic Development in the province; and future transportation and infrastructure projects in BC.
- 34. Strata Health Solutions Inc. is lobbying public office holders at several public agencies in regard to the use of end-to-end health care referral software that matches patients to the most appropriate care setting quickly, reducing the workload of medical professionals and administrative staff and improving the quality of care for patients.
- 35. United Parcel Service Canada Ltd. is lobbying public office holders at several public agencies regarding the government's greenhouse gas reduction regulation.
- 36. Western Dairy Council is lobbying public office holders at the Ministry of Agriculture, Food and Fisheries seeking provincial support for a Grocery Industry Code of Practice to advance national implementation.
