

WHO'S LOBBYING WHO IN BC? Monthly Snapshot – November 2025

The following is a brief summary of new Registration Returns activated or re-activated between November 1 and November 30, 2025, under BC's *Lobbyists Transparency Act*.

- 1. Kerry Allerton, a consultant lobbyist with 3Sixty Public Affairs Inc., is lobbying public office holders at several public agencies on behalf of Adult Vaccine Alliance / Alliance Vaccins pour Adultes seeking to strengthen provincial adult immunization programs, and to discuss how the provinces can work with the federal government and other provincial and territorial governments to ensure that adult vaccines recommended for use by the National Advisory Committee on Immunizations are publicly funded and accessible to adults.
- James Barley, a consultant lobbyist with Strategies North Advisory Inc., is lobbying public office
 holders at several public agencies on behalf of Spuzzum First Nation advocating for increased
 spending to support on-reserve social services, infrastructure, and economic development
 opportunities.
- 3. Berit Beattie, a consultant lobbyist with CSG Canadian Strategy Group LP, is lobbying public office holders at several public agencies on behalf of Kerkhoff Construction LTD. seeking provincial government support for the 580 Commonage housing project in Vernon and aligning the project with provincial priorities for rural development, infrastructure investment, and sustainable land use.

- 4. Alexander Bernst and Aidan Grove-White, consultant lobbyists with StrategyCorp Inc., are lobbying public office holders at several public agencies on behalf of Waymo LLC regarding the development of legislation and regulation for autonomous vehicles.
- 5. Emma Rose Blair and Marie Lemieux, consultant lobbyists with PAA Advisory | Conseils, are lobbying public office holders at several public agencies on behalf of Owens Corning Canada Holdings ULC regarding Owens Corning's network updates in BC and Canada as well as support to the local economy and Canada-U.S. relations and B.C. economic resilience.
- 6. Lee Boswell, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of Live Nation Canada, Inc. regarding Live Nation's role in the Canadian live event marketplace and discuss opportunities to grow arts and cultural experiences.
- Lee Boswell, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of Ticketmaster Canada ULC regarding the Ticket Sales Act, 2019 and associated regulations.
- 8. Erin Co, a consultant lobbyist with Global Public Affairs Inc., is lobbying public office holders at several public agencies on behalf of Canadian Steel Producers Association regarding budgets as they relate to infrastructure, including measures associated with economic stimulus spending as well as ongoing infrastructure spending programs, economic and business conditions affecting the steel industry globally as well as in Canada and B.C., including monetary and fiscal policies and policies and programs in relation to international steel trade and measures to improve the competitiveness of the domestic steel industry.
- 9. Erin Co, a consultant lobbyist with Global Public Affairs Inc., is lobbying public office holders at the Ministry of Health and the Ministry of Social Development and Poverty Reduction on behalf of Prosthetic and Orthotic Association of British Columbia regarding program modernization to ensure more comprehensive and affordable coverage for British Columbians who require prosthetic and/or orthotic care.
- 10. Dan Davies, a consultant lobbyist with Davies North & Associates, is lobbying Member(s) of the BC Legislative Assembly and public office holders at the Ministry of Forests on behalf of Hotsaw Logging Ltd. regarding the challenges of being a woodlot holder; raising issues around lack of permitting happening and a critical issue around forest health and fire mitigation in forests in NE BC; offered assistance to work with ministry to improve forest management practices and help

- with developing policy/legislation, and implored the ministry to help achieve the required harvesting permits to achieve the above points.
- 11. Dan Davies, a consultant lobbyist with Davies North & Associates, is lobbying Member(s) of the BC Legislative Assembly and public office holders at the Ministry of Forests on behalf of Livingston Timber Ltd regarding the challenges of being a woodlot holder; raising issues around lack of permitting happening and a critical issue around forest health and fire mitigation in forests in NE BC; offered assistance to work with ministry to improve forest management practices and help with developing policy/legislation, and implored the ministry to help achieve the required harvesting permits to achieve the above points.
- 12. Leila Farmer, a consultant lobbyist with Global Public Affairs Inc., is lobbying public office holders at several public agencies on behalf of Powell River Energy Inc regarding Powell River Energy Inc.'s hydro facilities and the provincial government's energy priorities.
- 13. Blair Feltmate, a consultant lobbyist with JFK LAW LLP, is lobbying public office holders at several public agencies on behalf of Te'mexw Treaty Association regarding finalizing BC Modern Treaty Process with Te'mexw Treaty Association and supporting member nation with specific request regarding grave sites.
- 14. Nina Fourie, a consultant lobbyist with Framepoint Public Affairs, is lobbying public office holders at several public agencies on behalf of Borealis Biosciences Canada, Inc. seeking funding for drug discovery project.
- 15. Steve Greenaway, a consultant lobbyist with Counsel Public Affairs Inc., is lobbying public office holders at several public agencies on behalf of White Ribbon regarding gender-based violence prevention programming and services.
- 16. Steve Greenaway and Darielle Segovia, consultant lobbyists with Counsel Public Affairs Inc., are lobbying public office holders at several public agencies on behalf of Canadian News Media Association regarding Canada's news publishers and local journalism.
- 17. David Gulliver and Safia Mohamed, consultant lobbyists with Enterprise Canada, are lobbying public office holders at several public agencies on behalf of Kids Help Phone educating the Government on Kids Help Phone's efforts in providing free, 24/7 mental health services for young people in Canada and to seek opportunities to work with the government to advance mental health initiatives and supports for young people in BC.

- 18. David Gulliver, a consultant lobbyist with Enterprise Canada, is lobbying public office holders at several public agencies on behalf of Netflix Services Canada ULC regarding regulatory and policy issues affecting content creating and streaming service providers, including tax incentives, to promote a robust film, television and animation sector in British Columbia.
- 19. Nicola Hill, a consultant lobbyist with Hilltop Public Affairs Corp., is lobbying public office holders at several public agencies on behalf of Hope Air regarding maintaining support for medical travel programs that will be key to ensuring uninterrupted access to care for patients in rural and remote regions.
- 20. Mark Jiles, a consultant lobbyist with Bluestone Government Relations, is lobbying public office holders at several public agencies on behalf of New Car Dealers of British Columbia to change luxury tax policy so that it better reflects vehicle prices, for annual funding for the GO Electric point-of-sale incentives program, and to work with the Province on the rollout of the ZEV mandate by highlighting pricing, availability, and potential impacts on the dealer network in BC.
- 21. Mark Jiles and Rob Nagai, consultant lobbyists with Bluestone Government Relations, are lobbying public office holders at the Ministry of Infrastructure, Water, Land and Resource Stewardship on behalf of BC Water and Waste Association regarding establishing BC Water and Waste Association as the association of record for local and provincial governments when considering drinking water and effluent legislation as well as a resource for government to understand the operating realities of BC's water systems and infrastructure.
- 22. Michael McKinnon, a consultant lobbyist with Enterprise Canada, is lobbying public office holders at several public agencies on behalf of Flair Airlines Ltd. discussing opportunities, including policies and financial incentives, to support economic growth, tourism and affordability by encouraging more affordable and accessible air travel to and from British Columbia.
- 23. Safia Mohammed, a consultant lobbyist with Enterprise Canada, is lobbying public office holders at several public agencies on behalf of British Columbia Association of Community Health Centres regarding opportunities to strengthen public health care by expanding the community health centre model of primary care delivery throughout the province.
- 24. Allie Meeres, a consultant lobbyist with Sedgwick Strategies Inc., is lobbying public office holders at several public agencies on behalf of Osisko Development Corp. regarding Indigenous equity opportunities in major projects.

- 25. Robin Phillips, a consultant lobbyist with JFK Law LLP, is lobbying public office holders at the Ministry of Indigenous Relations and Reconciliation on behalf of Te'mexw Treaty Association supporting in meetings at the First Nations Leadership Gathering with Ministers and other public office holders to discuss Treaty negotiation progress.
- 26. Mae Price, a consultant lobbyist with JFK LAW LLP, is lobbying public office holders at the Ministry of Transportation and Transit on behalf of Beecher Bay First Nation Band Council, regarding the past use of reserve lands.
- 27. Katie Shaw, a consultant lobbyist with Falkirk Consulting, is lobbying public office holders at several public agencies on behalf of Northisle Copper and Gold Inc. regarding the North Island Project's regulatory roadmap, infrastructure needs, and alignment with provincial priorities for critical minerals, clean energy, and regional economic development.
- 28. Katie Shaw, a consultant lobbyist with Falkirk Consulting, is lobbying public office holders at several public agencies on behalf of Scottie Resources Corp. regarding opportunities for collaboration with government and Indigenous partners; ensure clarity and alignment on regulatory processes; and support commitments to reconciliation, responsible development, and economic opportunity in the region.
- 29. Katie Shaw, a consultant lobbyist with Falkirk Consulting, is lobbying public office holders at the Office of the Premier and the Ministry of Post-Secondary Education and Future Skills on behalf of Lululemon Athletica Canada Inc., regarding spousal Open Work Permit Policy changes as it relates to employment opportunities in Canada.
- 30. Katie Shaw, a consultant lobbyist with Falkirk Consulting, is lobbying public office holders at several public agencies on behalf of Regeneration Rehabilitation Services (Canada) Inc. regarding its nature-positive approach to mine waste remediation and reclamation, and to identify opportunities for collaboration with government, Indigenous Nations, and Crown agencies.

 Communications will focus on advancing policies, partnerships, and pilot projects that align with provincial objectives for environmental restoration, critical minerals recovery, and sustainable economic development.
- 31. Bill Tieleman, a consultant lobbyist with West Star Communications, is lobbying public office holders at several public agencies on behalf of College of Physicians and Surgeons of British Columbia regarding the College's concerns about inclusion in the "government reporting entity" definition under the Budget Transparency and Accountability Act and of being considered a

- "government corporation" under the Financial Administration Act as a result of the coming into force of the Health Professions and Occupations Act on April 1, 2026.
- 32. Steve Vander Wal, a consultant lobbyist with Rocky Point Public Affairs, is lobbying public office holders at the Ministry of Health on behalf of BC Psychological Association advocating for the integration of registered psychologists into BC's health care and public policy systems.
- 33. Samira Wagner, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of SenseNet Inc. regarding several matters including: data governance policies that support ethical use of AI-enabled wildfire surveillance tools, the establishment of technical guidelines and policy frameworks that integrate wildfire detection technologies into emergency response and climate adaptation planning, collaborate on public communications strategies and public education efforts related to wildfire readiness and early detection, development policies that support clean technology innovation, job creation, and export readiness in the wildfire prevention and resilience sector, dedicated line item within the BC Wildfire Service budget to support proactive wildfire detection and prevention technologies, provincial procurement frameworks to allow for expedited BC Bid qualification, vendor preapproval, and preferential consideration for British Columbia—based wildfire technology companies and the development or expansion of provincial grant programs, including the BC Centre for Innovation and Clean Energy (CICE) and the Community Emergency Preparedness Fund.
- 34. Leah Ward, a consultant lobbyist with Wellington Advocacy Inc., is lobbying public office holders at the Ministry of Energy and Climate Solutions on behalf of NNC Midstream Partners Inc. (NNC-MPI) seeking to discuss the development of new export market access for Canadian natural resource products.
- 35. Matthew Wigmore, a consultant lobbyist with Framepoint Public Affairs, is lobbying public office holders at several public agencies on behalf of Apple Canada Inc. arranging meetings for clients for the purposes of expanding business in the Province of BC.
- 36. B.C. CRANBERRY GROWERS ASSOCIATION is lobbying Member(s) of the BC Legislative Assembly regarding prioritizing recruitment and retention for key program positions.
- 37. BC Federation of Students is lobbying public office holders at several public agencies regarding inclusion of post-secondary education and other topics affecting young people in COVID economic recovery plans, increased funding to public post-secondary institutions and reduced user fees, increased non-repayable financial aid for students in post-secondary education, including trades,

regulation of the international education sector, including development of an international education strategy, the creation of a strategy to increase enrolment in skilled trades programs and increase their success in apprenticeship, Post-Secondary Funding Formula Review and implement a new funding model that provides long-term financial stability for institutions, restore provincial funding to BC's public institution to not less than 75% of institutional budgets and enforcement of the Tuition Limit Policy to maintain the 2% cap on domestic fee increases.

- 38. B.C. Pork Producers Association is lobbying public office holders at several public agencies regarding policies and regulations to the benefit of the BC hog sector.
- 39. BC Raspberry Industry Development Council is lobbying public office holders at the Ministry of Agriculture and Food regarding recruitment and retention for key program position.
- 40. BC Turkey Association is lobbying public office holders at the Ministry of Agriculture and Food regarding recommendations on agriculture legislation.
- 41. BluEarth Renewables Inc. is lobbying public office holders at several public agencies regarding specific concerns related to the Logan solar project (e.g., Logan solar development, BC Energy Regulator regulatory process and avoiding regulatory duplication, project security requirements, interconnection costs); regarding Property Tax Assessments for solar and wind projects generally and specifically solutions related to mitigating Property Tax for the quA-ymn Solar project; policy and program recommendations to achieve our provincial greenhouse gas emission reduction targets and attract investment to the province, specifically in the area of renewable energy through development of power call and future power calls.
- 42. The British Columbia Egg Producers Association is lobbying public office holders at the Ministry of Agriculture and Food and the Ministry of Environment and Parks regarding the restrictions on rodenticides.
- 43. Canadian Gaming Association is lobbying public office holders at several public agencies regarding the *Provincial Gaming Control Act*, gaming regulations, policy matters related to Provincial gaming marketplace.
- 44. Carbon Removal Canada is lobbying public office holders at several public agencies regarding policy and program recommendations regarding the inclusion of carbon removal technologies in BC's output based pricing system, Low Carbon Fuel Standard, and other potential carbon credit markets, and regarding funding programs or mechanisms that could stimulate development of carbon removal projects in BC.

- 45. Ceemingly Inc is lobbying public office holders at several public agencies regarding implementing their software into school systems for students seeking employment and employment insurance compliance.
- 46. Coloplast Canada Corporation is lobbying public office holders at several public agencies regarding access to and coverage of medical devices (including catheters) and other related health care services.
- 47. Earthjustice is lobbying public office at several public agencies regarding pausing approvals for mining projects along the Alaska-BC transboundary rivers until BC regulators secure the free, prior, and informed consent of downstream Tribal Nations.
- 48. The Elizabeth Fry Society of Greater Vancouver is lobbying public office holders at several public agencies regarding expanding access to multi-year funding agreements to support efficient and effective non-profit programs and services, and increasing all project-based funding's percentage of allowable core or administrative costs beyond the common 5-15% limit.
- 49. Fédération des francophones de la Colombie-Britannique is lobbying public office holders at several public agencies to collaborate with the Federal Government and the Provincial Francophone Affairs Program (Intergovernmental Relations Secretariat) to implement and evaluate federal-provincial agreements and to represent its 39 members.
- 50. Gabriola Island Chamber of Commerce is lobbying public office holders at several public agencies recommending expanding access to multi-year funding agreements and recommending increasing all project-based funding's percentage of allowable core or administrative costs beyond the common 5-15% limit.
- 51. Greater Victoria Harbour Authority is lobbying public office holders at several public agencies regarding support and funding for Shore Power project, support of contingencies to service cruise ships in Victoria during possible labour disruption and the return of unspent funding.
- 52. JTI Macdonald is lobbying public office holders at several public agencies regarding any new legislative or regulatory proposals or policies relating to tobacco and/or vaping including taxation, product regulation, flavouring, packaging and labeling requirements, contraband and general border security policy.
- 53. Owens Corning Canada Holdings ULC is lobbying public office holders at several public agencies regarding Canada-U.S. relations and B.C. economic resilience and network updates in BC and Canada as well as support to the local economy.

- 54. PRI Association is lobbying public office holders at the Ministry of Finance and the Ministry of Environment and Parks regarding global investor perspectives on climate change as part of the Collaborative Sovereign Engagement on Climate Change initiative.
- 55. Supporting Women's Alternatives Network (SWAN Vancouver) Society is lobbying public office holders at several public agencies for increased access to justice, labour protections, and healthcare for im/migrant sex workers.
- 56. Re:wild is lobbying Member(s) of the BC Legislative Assembly regarding an open letter to the entire federal government of Canada and to the British Columbia government: Sovereign Tribes in Southeast Alaska have not consented to rapid mining development occurring in the headwaters of the transboundary rivers that they have depended on since time immemorial. The Tribes are already seeing the impact of Canadian mining projects on their lands we urge you to honour your international human rights obligations and recognise their right to deep consultation on development decisions across the three watersheds at the heart of the mining development: The Taku/T'aaku Héeni (Tlingit), Stikine/Shtax'heen (Tlingit) and Unuk/Joonax (Tlingit).
- 57. Spinal Cord Injury Organization of British Columbia is lobbying public office holders at several public agencies advocating for greater flexibility in the allowable percentage for administrative/core operating costs in funding agreement, for the provision of multi-year funding agreements, and for greater awareness and recognition of the BC non-profit sector and the role it plays in BC's economy.
- 58. United Flower Growers is lobbying public office holders at several public agencies regarding updating the revenue thresholds for farm classification; increasing the list of items included in the PST exemption list for Agriculture; encouraging the Government to work with industry to ensure long term access to water; and encouraging the Government to work with industry to avoid further cost pressures on the sector.
- 59. University of Victoria Graduate Students' Society is lobbying public office holders at several public agencies regarding affordable housing in the Victoria region, anti-racism, anti-colonialism, and other human rights, equity, diversity and inclusion issues, rights of graduate students under the Ministry of Advanced Education, Skills and Training related to graduate funding, research, housing, living conditions, mental health and addictions, divestment from non-renewable energy and climate emergency mitigation, weapons manufacturing and other industries financially benefitting from global conflict and permanent extension of the BC Graduate Scholarship.

60. Waymo LLC is lobbying public office holders at several public agencies regarding the deployment of autonomous driving technologies in British Columbia and the potential development of laws and regulations related to autonomous driving technologies, including as it relates to operational authorizations, commercial operations, goods delivery operations and ridehail operations.
