

# WHO'S LOBBYING WHO IN BC?

## Monthly Snapshot – January 2026

The following is a brief summary of new Registration Returns activated or re-activated between January 1 and January 31, 2025, under BC's *Lobbyists Transparency Act*.

1. Jennifer Anthony, a consultant lobbyist with Upstream Strategy Group, is lobbying public office holders at the Ministry of Health and Member(s) of the BC Legislative Assembly on behalf of Abbott Diabetes Care / Abbott Soins du Diabète to discuss options for expanding public reimbursement for advanced glucose monitoring systems.
2. Jennifer Anthony, a consultant lobbyist with Upstream Strategy Group, is lobbying public office holders at several public agencies on behalf of Turo Canada Co. ULC advocating for fairness in public policy and taxation as it relates to Turo's peer-to-peer car share hosts and guests.
3. Zach Authier, a consultant lobbyist with Global Public Affairs, is lobbying public office holders at several public agencies on behalf of Barkley Project Group Limited advocating for more collaborative approaches to permitting with First Nations on renewable energy projects, and for economic reconciliation through Indigenous equity in electrical transmission and distribution infrastructure on Vancouver Island.
4. Berit Beattie, a consultant lobbyist with CSG Canadian Strategy Group LP, is lobbying public office holders at several public agencies on behalf of Innovative Medicines Canada advocating for expanding research, investment, and job creation opportunities in British Columbia's life sciences and research and development ecosystem; advocating for innovative procurement of medicines within the health system to improve patient outcomes, including approaches that leverage real-

world data to assess effectiveness; to ensure patient access to innovative medicines, support continued research investment, and encourage federal advocacy on the proposed Patented Medicine Prices Review Board regulatory changes; and to ensure recognition of the value of Innovative Medicines in improving patient outcomes, enhancing system efficiency, and fostering economic growth through sustained investment in the drug plan.

5. Michael Cunningham, a consultant lobbyist with Graphite Public Affairs, is lobbying public office holders at several public agencies on behalf of DoorDash Technologies Canada Inc. regarding food delivery services and government policies impacting commissions and service delivery fees, and gig economy and precarious worker strategy.
6. Michael Cunningham, a consultant lobbyist with Graphite Public Affairs, is lobbying public office holders at several public agencies on behalf of Pfizer Canada ULC/Pfizer Canada SRI regarding public funding or policy decisions relating to Pfizer's innovative medicines portfolio and vaccine products.
7. Leila Farmer and Beatriz Grigsby-Larson, consultant lobbyists with Global Public Affairs Inc., are lobbying public office holders at several public agencies on behalf of Barkley Project Group Limited regarding economic reconciliation through Indigenous equity in electrical transmission and distribution infrastructure on Vancouver Island, as well as to advocate for more collaborative approaches to permitting with First Nations on renewable energy projects and to discuss opportunities to collaborate on the Tu Deh-Kah Geothermal project.
8. Steve Greenaway, a consultant lobbyist with Counsel Public Affairs Inc., is lobbying public office holders at the Ministry of Health on behalf of Isologic Innovative Radiopharmaceuticals Ltd. to expand British Columbians' access to Positron Emission Tomography (PET) radiopharmaceuticals.
9. Mark Jiles, a consultant lobbyist with Bluestone Government Relations, is lobbying public office holders at the Ministry of Agriculture and Food on behalf of Maan Farms Ltd. to advocate to the Province of British Columbia for the creation of a new certification category for berry wines.
10. Mark Jiles and Rob Nagai, consultant lobbyists with Bluestone Government Relations, are lobbying public office holders at several public agencies on behalf of Surrey Urban Mission Society to seek funding for housing and homelessness initiatives from BC Housing Management Commission.
11. Damien Kurek, a consultant lobbyist, is lobbying Member(s) of the BC Legislative Assembly on behalf of Valory Resources Inc. to discuss the status of the organization's Alberta projects and the metallurgical coal sector in British Columbia.

12. David MacLean, a consultant lobbyist with Earnscliffe Strategies, is lobbying public office holders at the Ministry of Health on behalf of Insulet Canada Corporation to secure pharmacare coverage for the ominpod under the BC Pharmacare regime.
13. Ashley McDougall, a consultant lobbyist with Impact Public Affairs, is lobbying public office holders at several public agencies on behalf of Insurance Brokers Association of British Columbia regarding the impacts of natural catastrophes and related adverse weather on British Columbians and the insurance landscape.
14. Michael McKinnon, a consultant lobbyist with Enterprise Canada, is lobbying public office holders at several public agencies on behalf of DoorDash Inc. in relation to government policies impacting food delivery services, including commissions and service delivery fees, as well as legislation relating to consumer issues.
15. Rob Nagai, a consultant lobbyist with Bluestone Government Relations, is lobbying public office holders at several public agencies on behalf of Icona Canada Properties Ltd. to engage with the Province of British Columbia to support the identification and delivery of affordable housing solutions.
16. Rob Nagai, a consultant lobbyist with Bluestone Government Relations, is lobbying public office holders at several public agencies on behalf of Maan Farms LTD regarding the creation of a new certification category for berry wines in the province.
17. Emiko Newman, a consultant lobbyist, is lobbying public office holders at several public agencies on behalf of Dogwood Initiative (Forest Futures) regarding changes to policies encouraging cleaner energy heating systems; a ban on advertising by fossil fuel companies; changes to the building code to remove fossil fuels from buildings; climate emergency policies; climate emergency and urging action to eliminate greenhouse gas emissions from new buildings; strengthening CleanBC targets and policies to address the climate emergency; and strengthening the Clean Transportation Action Plan targets and policies to address the climate emergency.
18. Katie Shaw, a consultant lobbyist with Falkirk Consulting, is lobbying public office holders at several public agencies on behalf of Flutter Entertainment plc regarding regulating private online gambling, including addressing the unregulated grey market in igaming, information on legal private frameworks in other jurisdictions in Canada and economic impacts for taxation if the province were to regulate private online gambling.

19. Don Stickney, a consultant lobbyist, is lobbying Member(s) of the BC Legislative Assembly and public office holders at the Ministry of Finance on behalf of Flutter Entertainment plc regarding regulating private online gambling, including information on legal private frameworks in other jurisdictions in Canada, and on the economic impacts for taxation if the province were to regulate private online gambling, including information on legal private frameworks in other jurisdictions in Canada and their economic impacts.
20. Bill Tieleman, a consultant lobbyist with West Star Communications, is lobbying public office holders at several public agencies on behalf of the National Police Federation/La Fédération nationale de la police regarding the ongoing police transition in Surrey as it relates to the BC Police Act, with the aim of providing information and recommendations to guide future decisions and to represent the interests of the organisation members across the province on matters of law enforcement, funding, and labour relations.
21. Samira Wagner, a consultant lobbyist with Crestview Strategy, is lobbying public office holders at several public agencies on behalf of Anglo American plc to engage with the Government of British Columbia on its critical minerals strategy and related policy development, including critical mineral project development, investment, and international trade.
22. Richard Zussman, a consultant lobbyist with Burson (Hill & Knowlton), is lobbying public office holders at several public agencies on behalf of Northeastern University regarding an invitation to visit Northeastern University's downtown Vancouver campus to gain a hands-on understanding of the institution's work supporting the province's workforce needs in the tech, AI, and innovation sectors, as well as discussions related to PAL allocations and the province's ongoing review of post-secondary institutions.
23. ARC Foundation is lobbying public office holders at the Ministry of Education and Child Care and Member(s) of the BC Legislative Assembly to advocate for funding related to their work to advance safe, caring, and inclusive schools.
24. Catalyst Community Developments Society is lobbying public office holders at several public agencies regarding increased investment in affordable housing across British Columbia, engagement with Ministers holding relevant housing, planning, and finance portfolios, and related municipal planning, housing policy, and taxation issues.
25. Coquitlam Teachers' Association is lobbying public office holders at several public agencies regarding curriculum changes; the availability of resources; timelines; in-service training;

instructional materials; collaboration time; data-gathering and assessment practices; communication; student learning and teaching conditions; the improvement of public education; seeking proper funding for public education; advocating for measures to address teacher recruitment and retention; and calling for a ceasefire in the Palestine–Israel conflict while denouncing Islamophobia, anti-Muslim hate, and antisemitism.

26. Dr. Richard Arseneau Inc. is lobbying Member(s) of the BC Legislative Assembly and public office holders at the Ministry of Health regarding changes to virtual group medical visit fee code items.
27. Dr R Jane McKay Inc. is lobbying public office holders at several public agencies regarding changes to virtual group medical visit fee code items.
28. International Association of Heat and Frost Insulators and Allied Workers Local 118 is lobbying public office holders at several public agencies regarding encouraging the provincial government to license asbestos removal and consulting firms; strengthening asbestos health and safety laws, rules, and regulations; promoting the use of appropriate mechanical insulation in buildings to conserve energy; promoting fair labour laws; and providing BCBT's position on Labour Code improvements, funding for skilled trades training, enhanced training standards for asbestos abatement workers, and enforcement of employer responsibilities related to the deliberate misclassification of workers.
29. Modular BC Association is lobbying public office holders at several public agencies, advocating for possible regulatory changes and requesting provincial funding to advance the organization's objectives of providing standardized modular solutions for multi-family homes.
30. NAIOP Vancouver Chapter, the Commercial Real Estate Development Association is lobbying public office holders at the Ministry of Housing and Municipal Affairs regarding Canadian development cost charges.
31. The Nature Trust of British Columbia is lobbying Member(s) of the BC Legislative Assembly and public office holders at the Ministry of Water, Land and Resource Stewardship regarding the Cowichan Estuary Restoration Project, the significant financial implications, and The Nature Trust of British Columbia's project partnership with both Cowichan Tribes and the Province.
32. North Okanagan-Shuswap Teachers' Association is lobbying public office holders at several public agencies regarding the Bargaining Table for teachers teaching in K-12 Public Education and the need for adequate funding for non-enrolling teaching, overcrowding in classrooms and increased ratios for counsellors at school.

33. Prince George Chamber of Commerce is lobbying public office holders at several public agencies regarding issues around public safety and the introduction of an involuntary care facility in Prince George, equalizing the investment to mental health and addiction counselling as is being invested in harm reduction, and increased investment in Northern BC highway infrastructure.
34. Princeton District Teachers' Union is lobbying public office holders at several public agencies advocating in support of a well-funded public education system that improves student learning conditions and teachers' working conditions, including classroom supports, addressing complex classroom needs, and teacher recruitment and retention.
35. Public Service Alliance of Canada, BC Region is lobbying Member(s) of the BC Legislative Assembly regarding BC's economic recovery plan, the positive impacts of sectoral bargaining, and the impact of the Phoenix pay system on federal government workers.
36. qathet Teachers' Association is lobbying public office holders at several public agencies regarding changes to advanced education, health, housing, science and technology, for teaching positions in public education K-12, policy and program recommendations regarding the government's stimulus response measures related to infectious diseases, economic recovery, specifically in the area of transportation/social justice/climate targets/cannabis distribution/infrastructure/energy/environment/taxation and finance etc, and seeking funding for finances and budgets, health, and information technology, and education.
37. SkipTheDishes Restaurant Services Inc. is lobbying public office holders at several public agencies regarding labour and benefit reforms aimed at improving the lives of independent couriers.
38. Strategic Natural Resource Consultants Inc. is lobbying public office holders at the Ministry of Forests regarding enhancing wildfire resourcing efficiency across British Columbia.
39. Suncor Energy Inc is lobbying public office holders at several public agencies regarding the interpretation and amendment of the Occupational Health and Safety Regulation, including as it relates to Threshold Limit Values (TLVs) for Benzene; factors and inputs to fuel pricing; opportunities for BC to advance effective support for clean technology development; low carbon fuels to inform and enable the most efficient and significant paths to GHG reductions; improve support investments in EV fast charging in BC; support and promote Suncor's current and potential operations; and fuel product supply and market access.

40. Thompson Region Division of Family Practice Society is lobbying Member(s) of the BC Legislative Assembly seeking increased funding for Primary Care Network clinical resources in the Thompson Region, per the original service plan approval.
41. Vancouver Elementary & Adult Educators' Society is lobbying public office holders at several public agencies regarding funding of education and all areas related to teacher working conditions, funding of public education, and student learning conditions and students well being.
42. Vancouver Island North Teachers' Association is lobbying public office holders at several public agencies regarding the bargaining table for Public Teachers and the need for adequate funding to address overcrowded classrooms, chronic staffing challenges and supporting student success.
