Who's Lobbying Who in BC? Monthly Snapshot – December 1 to December 31, 2011

The following organizations and consultant lobbyists submitted their registrations under the BC Lobbyists Registration Act between December 1 and December 31, 2011. The full details of each registration are searchable at www.lobbyistsregistrar.bc.ca.
