Who's Lobbying Who in BC? Monthly Snapshot – November 1-30, 2012

The following organizations and consultant lobbyists submitted their registrations under the BC *Lobbyists Registration Act* between November 1 and November 30, 2012. The full details of each registration are searchable at www.lobbyistsregistrar.bc.ca.

- Mike Bailey, a consultant lobbyist with Western Policy Consultants Inc., is coordinating meetings with the Minister of Health (and/or her staff) and a couple MLAs on behalf of his client, LEO Pharma Inc., to provide a briefing on the company's activities and innovative treatments for skin conditions.
- Mike Bailey and Carolyn Bailey, consultant lobbyists with Western Policy Consultants Inc., are setting up a meeting with the Minister of Health (and/or her staff) on behalf of Medinet Health Services Inc. to discuss public policy relating to further developing business of BC Health Organizations with government.
- 3. Mike Bailey and Carolyn Bailey are also setting up meetings with several public office holders on behalf of Hospital Transfer CA to discuss a regulatory change with regards to toll charges being applied to the company's vehicles on the Port Mann Bridge.

- 17. In-house lobbyists with the BC Association of Aboriginal Friendship Centres are lobbying a number of MLAs to establish an urban Aboriginal strategy that includes long-term investment in Aboriginal Friendship Centres.

- 18. In-house lobbyists with the BC Chamber of Commerce are lobbying a number of public office holders on a wide variety of topics including the commitment to the BC Agriculture Plan, water conservation and transmission planning.
- 19. In-house lobbyists with the B.C. Pharmacy Association are lobbing several public office holders on several topics including advocating the association's positions on the government's Drug Price Regulations and the implementation of the *Pharmaceutical Services Act*.
- 20. In-house lobbyists with Canada's Research-Based Pharmaceutical Companies (Rx&D) are lobbying a number of public office holders on a wide range of issues including business incentives for investment in BC, international trade agreements and greater access to innovative medicines for British Columbians.
- 21. In-house lobbyists with the Canadian Bankers Association are lobbying the Minister of Finance and the Minister of Justice and Attorney General on a number of issues including modification of the *Securities Act*, development of the Pooled Registered Pension Plans and development of elder financial abuse prevention policy.
- 22. In-house lobbyists with the Canadian Life & Health Insurance Association are lobbying various public office holders on a broad range of issues including generic drug pricing policy, HST/GST application to insurance policies and the development of *Insurance Act* regulations.
