Who's Lobbying Who in BC? Monthly Snapshot – October 1-31, 2012

The following organizations and consultant lobbyists submitted their registrations under the BC *Lobbyists Registration Act* between October 1 and October 31, 2012. The full details of each registration are searchable at www.lobbyistsregistrar.bc.ca.

- 1. Mike Bailey, a consultant lobbyist with Western Policy Consultants Inc., is arranging meetings with MLAs Adrian Dix (Vancouver-Kingsway) and Joe Trasolini (Port Moody-Coquitlam) on behalf of the Real Estate Institute of British Columbia to brief them on the organization's activities.
- 2. Ron Bailey and Brian Humphreys, in-house lobbyists with Nexen Inc., are lobbying the Minister of Energy, Mines and Natural Gas (and/or his staff) and the Minister of Environment for regulations that support the continued development of the company's shale gas resources in northern BC and the possible development of a liquid natural gas project.

Stephen Brown, an in-house lobbyist with the Chamber of Shipping of British Columbia, is lobbying several ministers on a number of topics including job creation in the BC maritime cluster and the International Maritime Centre as well as marine security, including the "Beyond the Border Initiative".
