Who's Lobbying Who in BC?

Monthly Snapshot - September 30, 2013

The following organizations and consultant lobbyists submitted their registrations under the BC *Lobbyists Registration Act* between September 1 and September 30, 2013.  Ministry staff on behalf of the International Society for Augmentative and Alternative
 Communication regarding the need for continued funding for Communication Assistance for
 Young Adults.

- 22. Don Stickney, a consultant lobbyist with Earnscliffe Strategy Group, is setting up meetings with several public office holders on behalf of the Alliance of Beverage Licensees to raise awareness of the group's position on the BC Liquor Policy review.
- 23. Danielle Takacs, a consultant lobbyist with Pathway Group, is coordinating introductory meetings with several ministers (and/or their staff) on behalf of BrightPath Kids to raise awareness of their early learning and child care development programs.
- 24. Bruce Young, a consultant lobbyist with Earnscliffe Strategy Group, is setting up meetings with staff of several ministers on behalf of EDP Renewables to share the company's specific renewable energy investment plans.
- 25. The Alliance of Beverage Licensees of BC is lobbying several public office holders to restrict gaming to age controlled establishments and to seek changes to policy, legislation and regulations that will keep the liquor primary and licensees retail business competitive.
- 26. The Automotive Retailers Association is lobbying several ministers on a broad range of topics including government support for automotive industry training programs and a new model for vehicle certification.
- 27. The BC Building Trades is lobbying several public office holders on a number of issues including improvements to health and safety and strengthening the B.C. apprenticeship system.
- 28. Brookfield Johnson Controls Canada is lobbying staff of the Minister of Technology, Innovation and Citizens' Services on contractual terms in respect of master service agreements for the

- delivery of property and project management, environmental/pollution prevention and technical value services.
- 29. The Canadian Cancer Society is lobbying several ministers and public servants on a number of issues which include seeking financial support for the CCS-UBC Cancer Prevention Centre.
- 30. Fortis BC Inc. is lobbying several public office holders on the purchase and sale of power, electricity rates and energy conservation.
- 31. Genome British Columbia is lobbying several public office holders to expand BC based genomics research.
- 32. GlaxoSmithKline is lobbying the Minister of Technology, Innovation and Citizens' Services on the value of GSK investments, the Minister of Health on the company's products, and several public agencies regarding the company's vaccines.
- 33. The Greater Victoria Chamber of Commerce is lobbying a number of public office holders on a broad range of topics including effective governance of Regional Transportation and a housing first policy.
- 34. The Guide Outfitters Association of British Columbia is lobbying an extensive list of public office holders on a range of topics including the proper stewardship of wildlife and providing input on the Allocation Policy to ensure conservation, fairness and industry viability.
- 35. Hewlett-Packard (Canada) Co. is lobbying several MLAs regarding government initiatives relating to IT cost savings and initiatives.
- 36. Johnson & Johnson Inc. is lobbying several ministers (and/or their staff) on health and trade policies and drug listings.
- 37. Pacific NorthWest LNG is lobbying a number of public office holders on a variety of issues including the impacts of an LNG export tax and electricity planning for LNG.
- 38. Sanofi-aventis Canada Inc. is lobbying the Minister of Health and other public office holders on reimbursement of pharmaceutical products on the drug formulary and strengthening the protection of intellectual property rights.
- 39. The Surrey Board of Trade is lobbying several public office holders on a variety of issues including skills development for youth, immigrants and refugee settlement and equitable funding for SFU Surrey and Kwantlen Polytechnic University.
- 40. The Truck Loggers Association is lobbying staff of the Minister of Forests, Lands and Natural Resource Operations to finalize the *Forestry Providers Protection Act*.

41. West Coast LEAF is lobbying several public office holders on a range of issues including greater
funding and increased access to legal aid.
